Three winning categories for the 2nd edition of the "De Sanctis Award for Human Rights"

On Tuesday 24th October 2023 at 16.00 hrs, in the presence of the First President of the Supreme Court of Cassation Margherita Cassano, the President of the De Sanctis Foundation Francesco De Sanctis and the President of the De Sanctis Award Gianni Letta, the three awardees identified by the Jury will receive their Award Medal at the Palace of Justice. The objective of the De Sanctis Award for Human Rights is to identify individuals who aim to guarantee Human Rights, i.e. the inalienable rights of man, to all members of a community.
